Section A-General Acknowledgement

Agricultural Societies Council of New South Wales Limited and <u>PARKES SHOW</u> (together the Suppliers), advise that participation (including passive participation) in animal handling or physical competitions or events at an agricultural show contains elements of risk, both obvious and inherent. The handling of animals if applicable is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt. Physical competitions, activities and events of all types are dangerous recreational activities.

By signing this waiver, I acknowledge that:

- participation in the Event is a recreational service for the purposes of section 139A of the Australian Competition and Consumer Act (Cth) 2010, and also a recreational activity for the purposes of section 5K of the Civil Liability Act (NSW) 2002:
- participation in the Event is a hazardous activity and involves a significant risk of physical harm and may result in injury, loss, damage or death to me;
- participation in the Event requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the Event;

- insects or other animals may cause animals used in the Event, if applicable, to become frightened and act in an unpredictable way;
- 1.8 if the Event involves the handling of animals, there is a risk of suffering injury including injuries caused by animals;
- 1.9 I am responsible for ensuring that I have and will wear equipment suitable for my safety in my participation the Event;
- 1.10 I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event;
- 1.11 I use the facilities supplied for the Event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me.

- 2. If I suffer personal injury or death while participating in an animal handling event, I will not hold the Suppliers, their employees or agents legally responsible for any personal injury or death I suffer.
